Dr. Anna Cheng Wai Fun is the Associate Consultant of the Department of Paediatrics, United Christian Hospital, Hospital Authority. She is the Paediatrician in charge of Comprehensive Child Development Service (CCDS) in Kowloon East Cluster in Hospital Authority since July 2007, responsible for early identification and collaborating with multidisciplinary professionals to deliver timely and holistic intervention for the at-risk mothers and their children, aiming to improve the physical, developmental and mental outcomes of these vulnerable children using community-based platform. Close collaboration with Hong Kong Lutheran Social Service since 2010 to deliver an integrated program to drug abusing mothers and their children (The physical and developmental outcomes of children whose mothers are substance abusers: Analysis of associated factors and impact of early intervention (2022) published in the Frontiers in Paediatrics, DOI 10.3389/fped.2022.1004890).
